In compliance with the requirements of the Pennsylvania Nonprofit Corporation Law of 1988 as amended, the undersigned, desiring to form a nonprofit corporation, hereby certifies that:

1) The name of the Corporation is:

ATTAWHEED FOUNDATION, INCORPORATED (the "CORPORATION").

2) The address of the Registered Office of the Corporation is: **1001 East Entry Drive, Pittsburgh, PA 15216, United States of America**

3) The purpose of the Corporation is to carry on Religious, Educational, and Charitable activities.

4) The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise.

5) Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not carry on any activity not permitted to be carried on by a corporation organized and operated exclusively for exempt purposes and which is an organization described in sections 501(c)(3), 509(a)(1), (2) or (3) of the Internal Revenue Code ("the Code"), or by an organization contributions to which are deductible under Section 170(c)(2) of the Code.

6) No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to any officer or director of the Corporation, or to any other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes as set forth herein.

7) The Corporation shall be governed and managed by a Board of Directors.

8) The Corporation shall have no members except members of the Board of Directors.

9) The Corporation shall be organized on a nonstock basis.

10) The term of existence of the Corporation shall be perpetual.

11) No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not


participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any or in opposition to any candidate for public office.

12) In the event of the dissolution of the Corporation or in the winding up of its affairs, or other liquidation of its assets, any remaining assets shall go to the Islamic Assembly of North America ("IANA" or "IANA CORP."), the Registered Agent and office of which on March 9, 1995 was Bassem K. Khafagi, 2323 S. Troy Street, #112-B, Aurora, CO 80014. If IANA does not exist at the time of dissolution or winding up the Corporation's affairs, the assets shall go to Dar Makkah Foundation of Denver, Colorado. If Dar Makkah does not exist, the assets shall go to any other Islamic Sunni organization chosen by the Board of Directors.
